If a non-qualifying agency is designated, UWNNS will redirect these funds to the Community Fund. DID YOU KNOW 70% of our children are not reading at grade level?

Early grade reading affects us right here in northern Nevada.

Children who aren't reading at grade level by the end of third grade are 4 times less likely to graduate from high school.

A high school diploma puts a young person on the path to a good job and life success.

Did you know a high school dropout is more likely to be unemployed, on welfare, or in prison?

So, what does this mean for us in northern Nevada?

A typical high school dropout has the skills to qualify for only 10% of new jobs. As our economy grows, we won't have the right people for the new jobs.

We're doubling the number children reading at grade level by the end of the third grade - by 2020.
